EXHIBITORS CONTRACT TERMS & CONDITIONS

- 1. Contract, this application, properly executed by applicant (exhibitor) shall, upon written acceptance by show official constitute a valid and binding contract.
- 2. Exhibitor may not sublease their space unless written permission is obtained from Show Officials prior to set up date. Space privileges will be revoked if this process is not followed as outlined above.
- 3. A deposit of 50% of Show fees are required with this application, with the balance due no later than eight (8) weeks before opening of show. Show fees will be refunded if 30 days notice is given in writing or directly to Show Official. A \$15.00 dollar fee will be charged to those not having their show fees paid on time as noted above!
- 4. Failure to occupy dealer's space within the first twelve (12) hours after shows first day opening will result on loss of show space, or not keeping someone within your booth at all times.
- 5. The Show Officials reserve the right to remove signs, printed matter, merchandise or exhibitor which in not in keeping with the shows purpose and character. We require exhibitors to have 90% rock related items in their booths. **NO FLEA MARKET ITEMS WILL BE ALLOWED!**
- 6. No selling of merchandise or demonstrating of products will be allowed on the Show grounds except by exhibitors of this year's show. Others will be asked to leave.
- 7. The Show Officials are not responsible for lost or stolen items, fire or any other cause of loss of merchandise or recreational vehicle, or property during said Show.
- 8. The exhibitor assumes all responsibility for compliance with all pertinent ordinances, regulations and codes of duly authorized, local, state, and federal governing bodies concerning fire, safety and health, together with the rules and regulations of the operators and/or owners of the property wherein the show is held.
- 9. In signing this contract, the exhibitor acknowledges that there are no representations between Show Officials and the exhibitors other than those contained in this contract.
- 10. No pets allowed inside show venue during show hours.
- 11. Exhibitors with children shall keep them from disturbing other dealers and be responsible for their actions during the duration of the show.
- 12. Drinking and/or unruly behavior will not be allowed on the grounds during show hours, as per contract.
